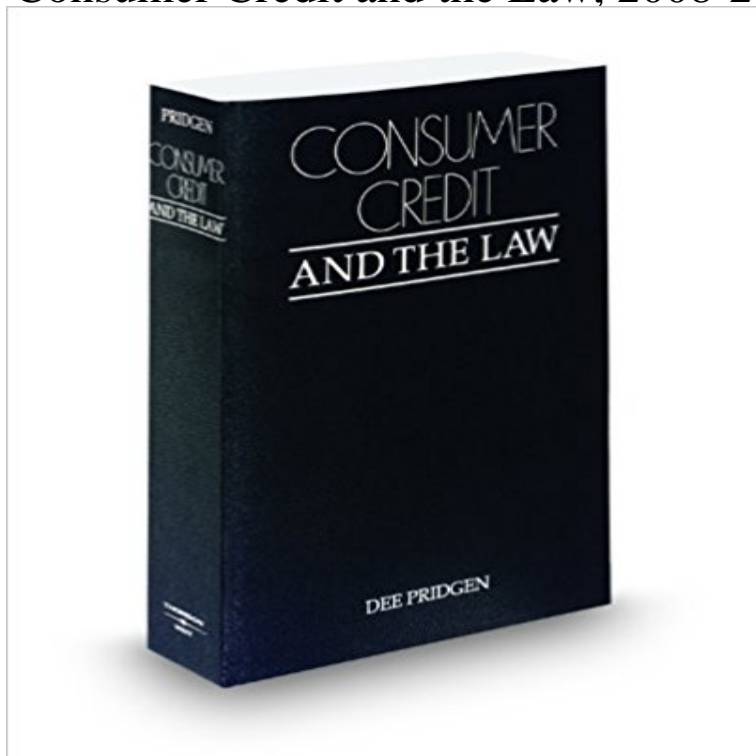


Consumer Credit and the Law, 2008-2009 ed.
