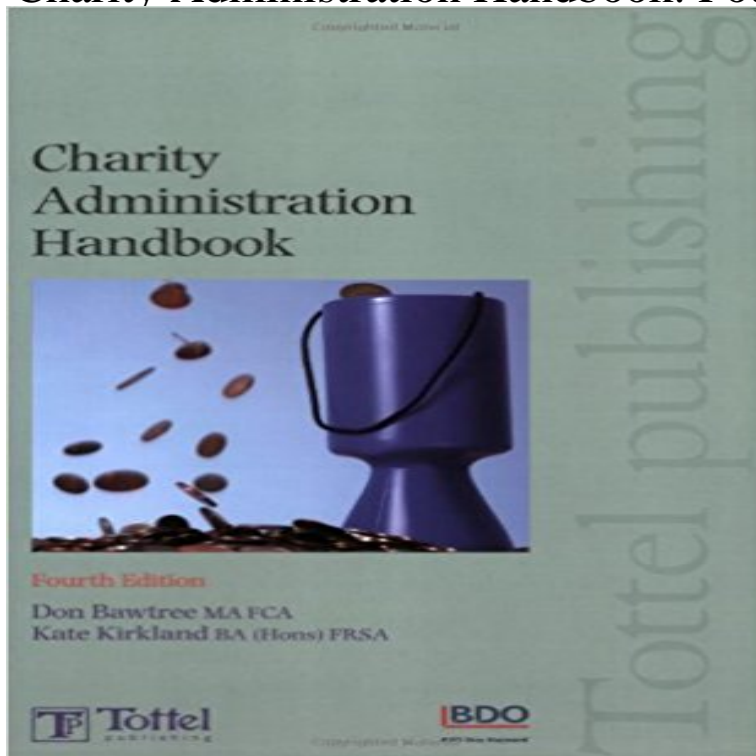


Charity Administration Handbook: Fourth Edition
