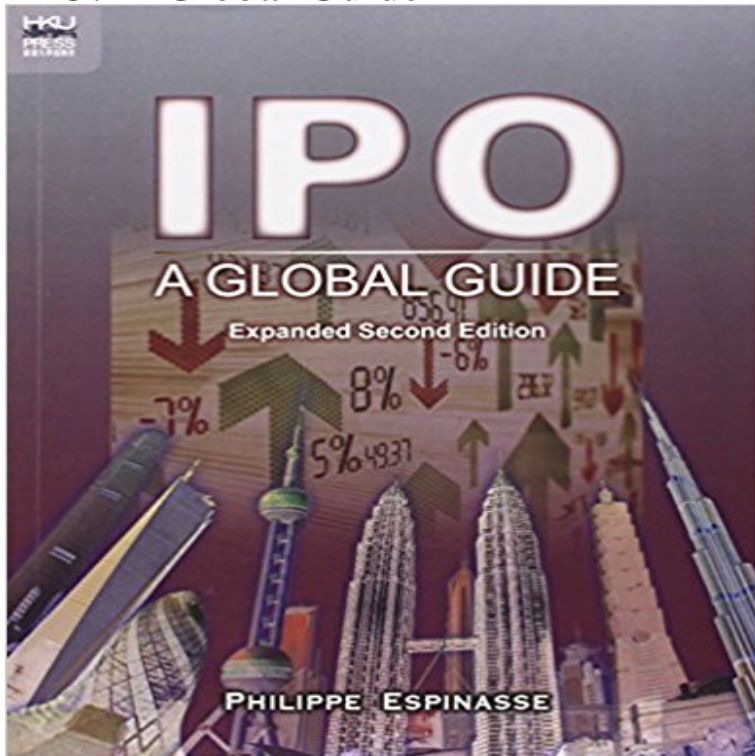


IPO: A Global Guide
