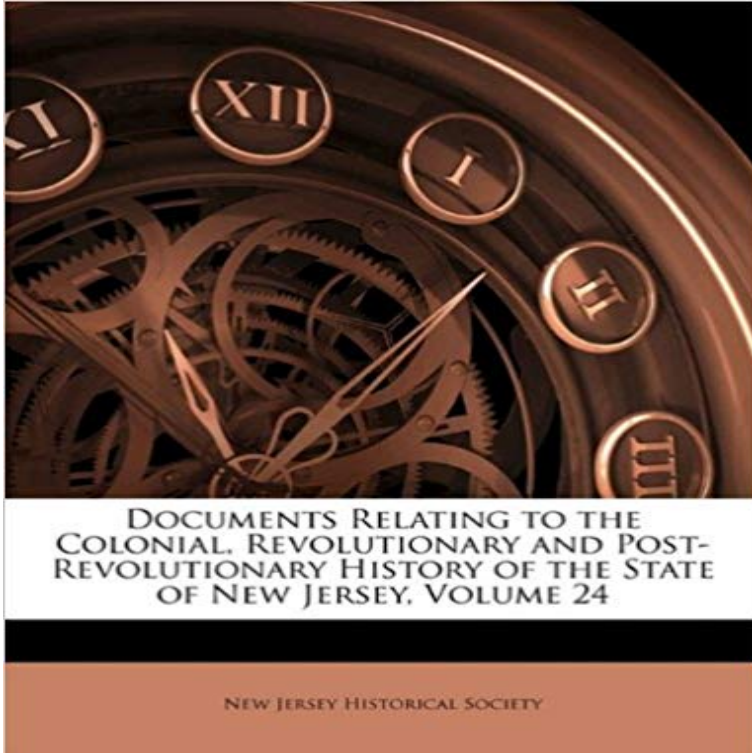


# Documents Relating to the Colonial, Revolutionary and Post-Revolutionary History of the State of New Jersey, Volume 24
