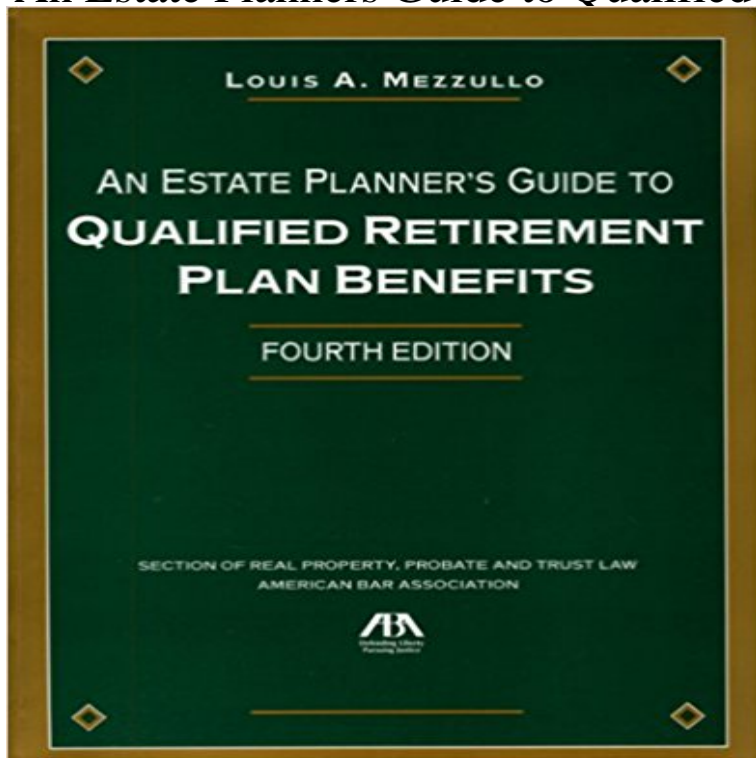


An Estate Planners Guide to Qualified Retirement Plan Benefits
