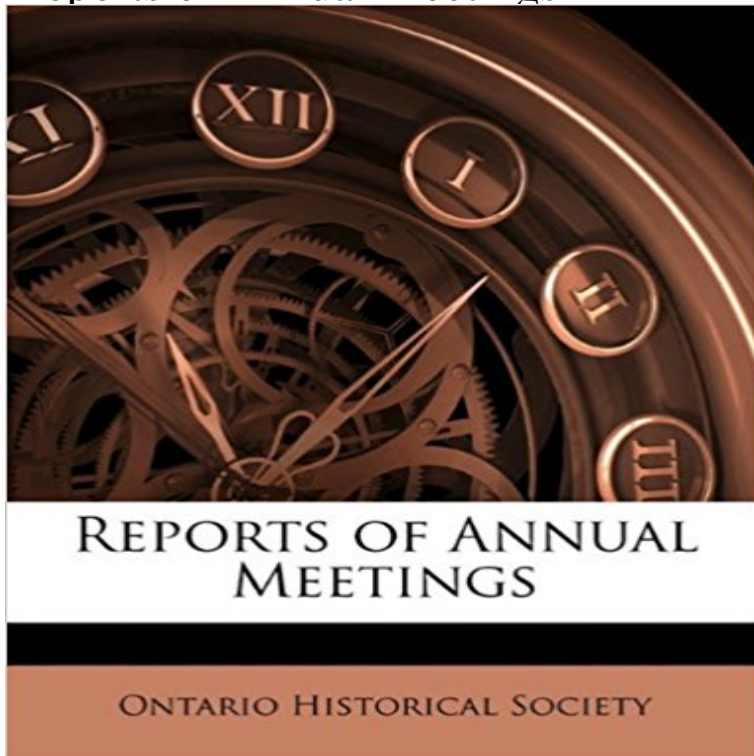


## Reports of Annual Meetings
