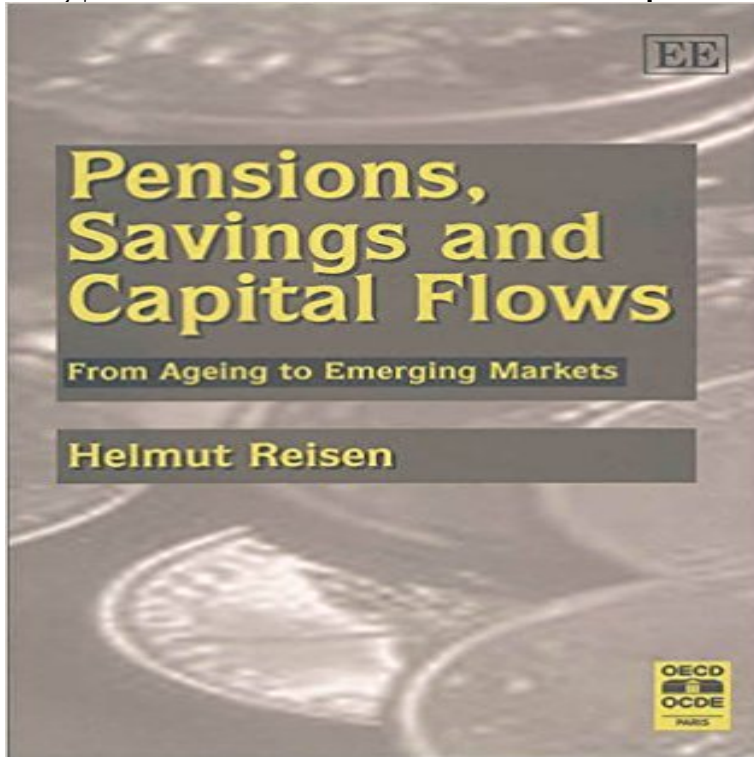


Pensions, Savings and Capital Flows (In Association with the Organisation for Economic Co-operation)
