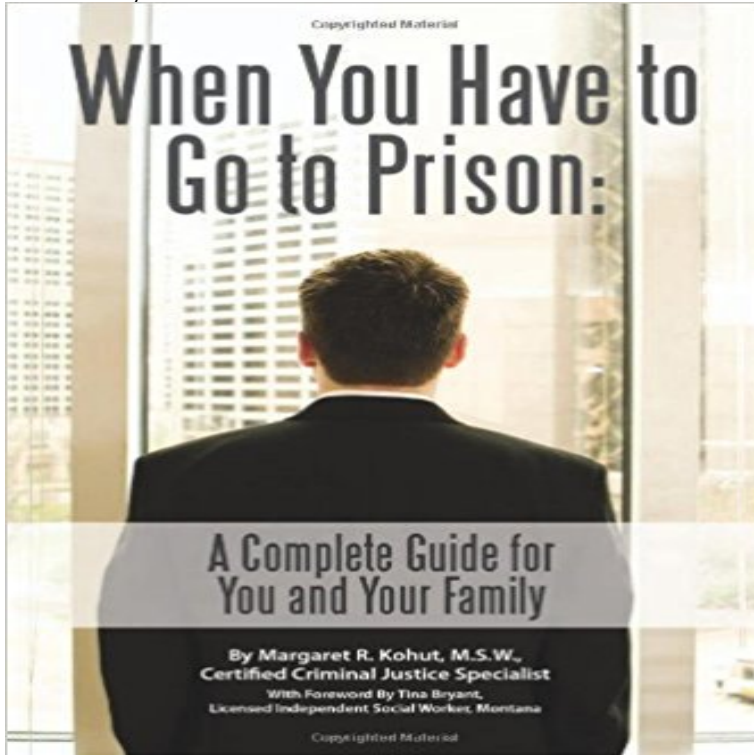


When You Have to Go to Prison: A Complete Guide for You and Your Family
