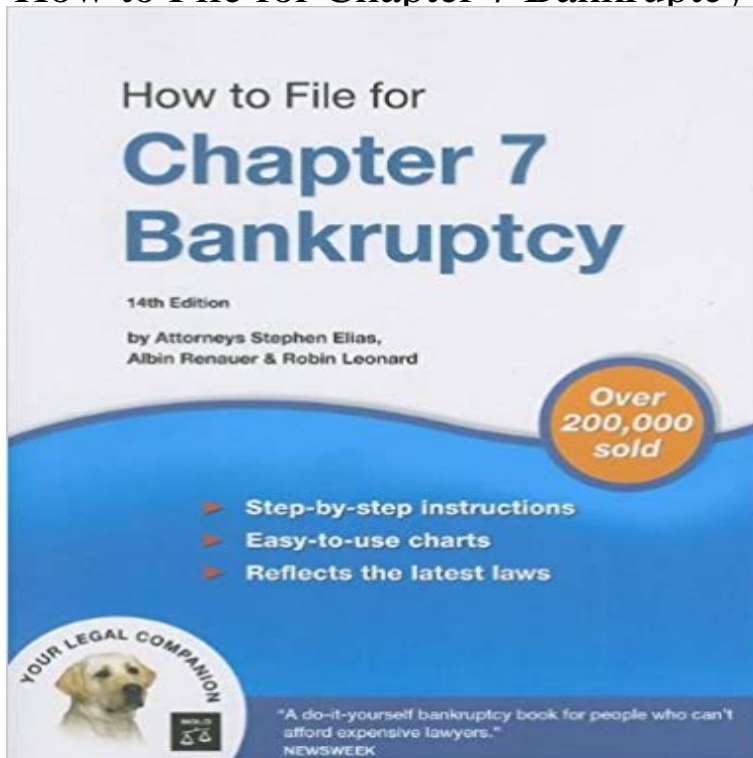


How to File for Chapter 7 Bankruptcy
