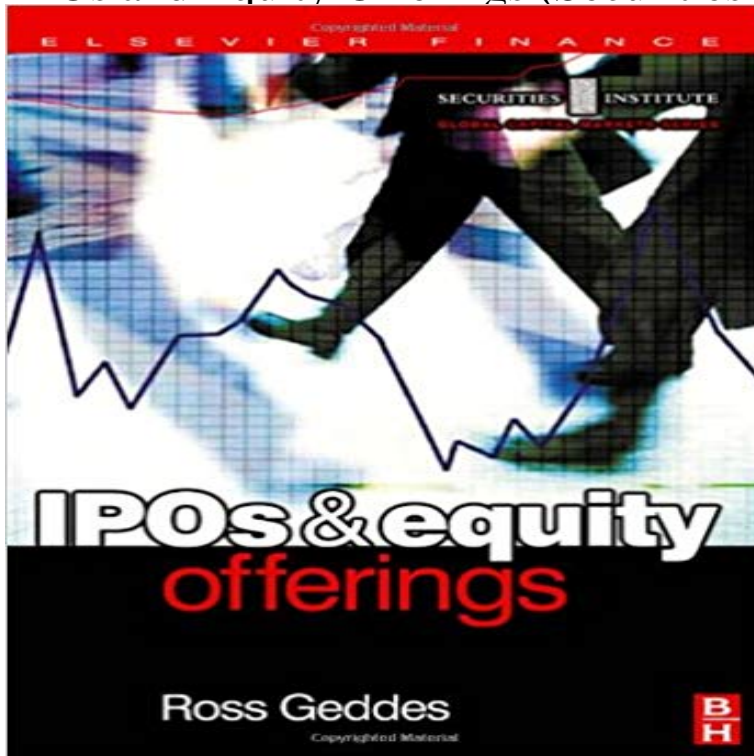


IPOs and Equity Offerings (Securities Institute Global Capital Markets)
