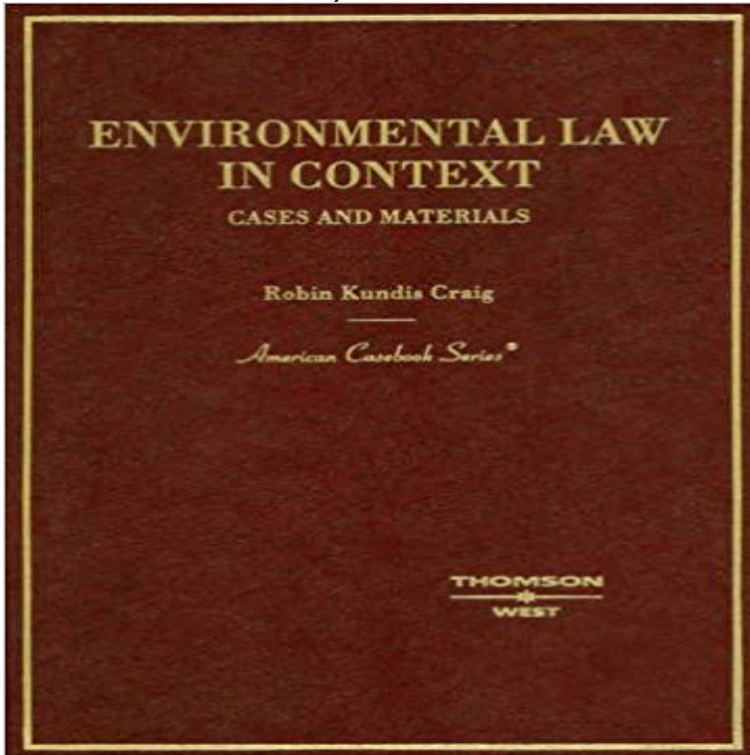


Environmental Law in Context: Cases, Materials and Statutes (American Casebook Series)
