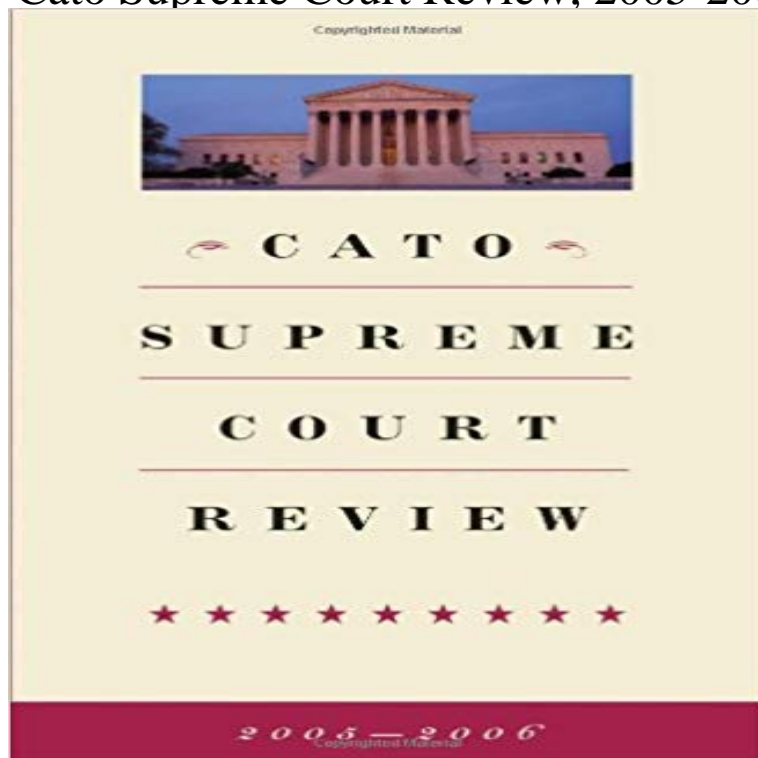


Cato Supreme Court Review, 2005-2006
