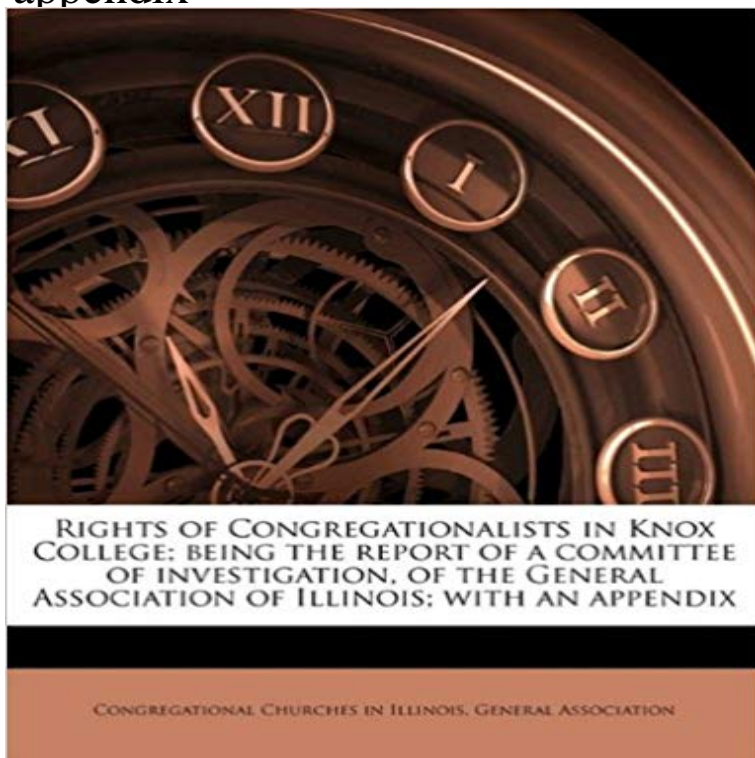


# Rights of Congregationalists in Knox College; being the report of a committee of investigation, of the General Association of Illinois; with an appendix
