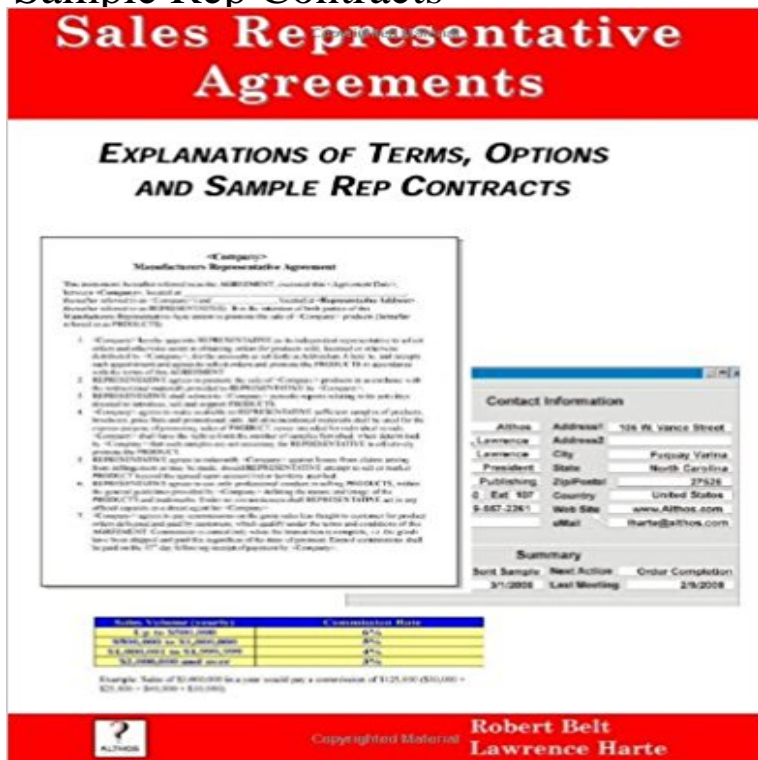


# Sales Representative Agreements, Explanations of Terms, Options and Sample Rep Contracts
