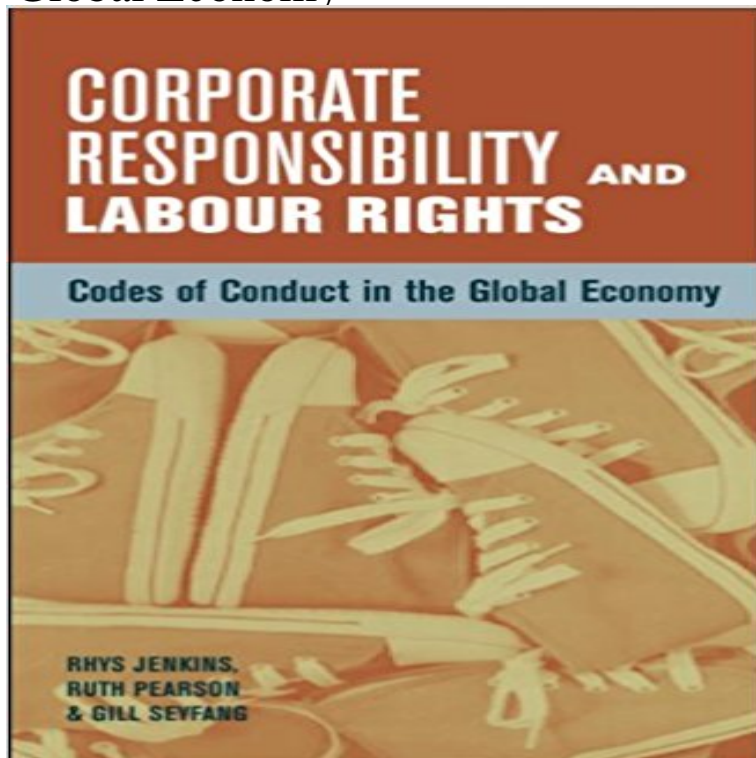


# Corporate Responsibility and Labour Rights: Codes of Conduct in the Global Economy
