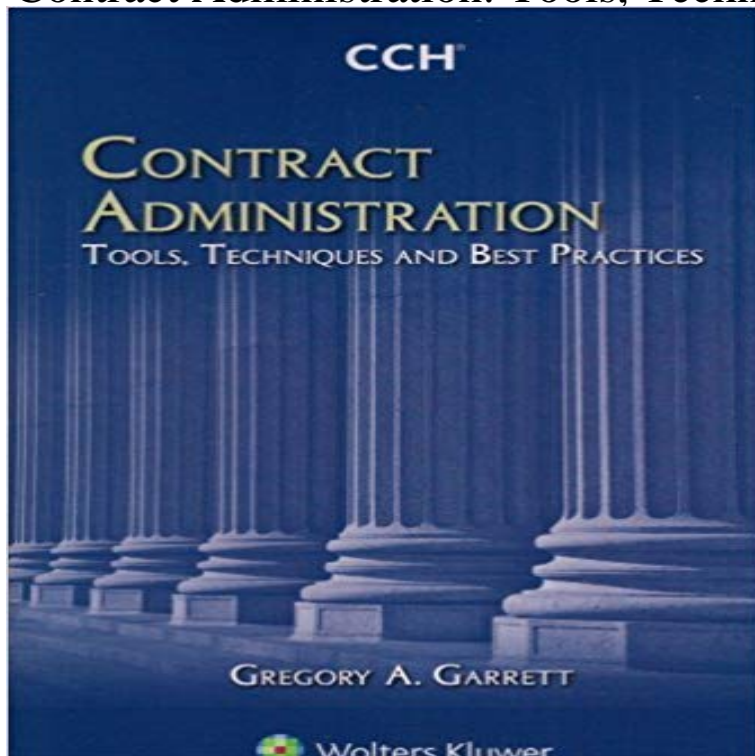


## Contract Administration: Tools, Techniques, and Best Practices
