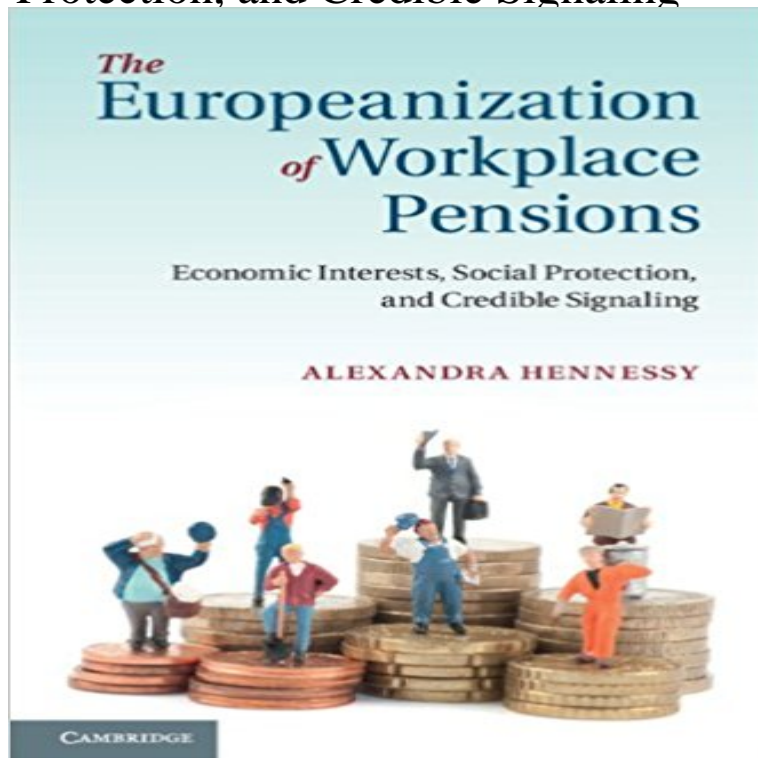


# The Europeanization of Workplace Pensions: Economic Interests, Social Protection, and Credible Signaling
