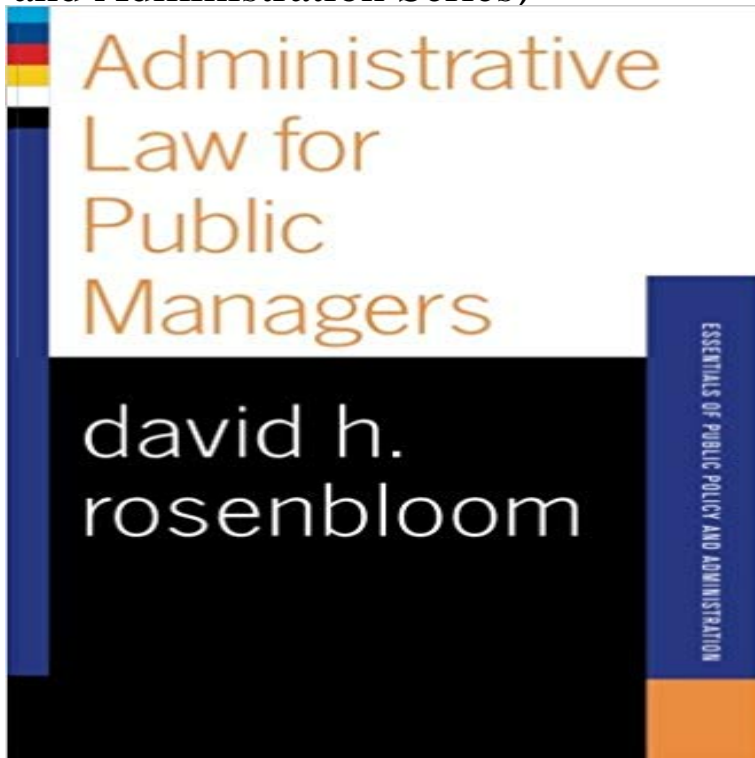


Administrative Law For Public Managers (Essentials of Public Policy and Administration Series)
