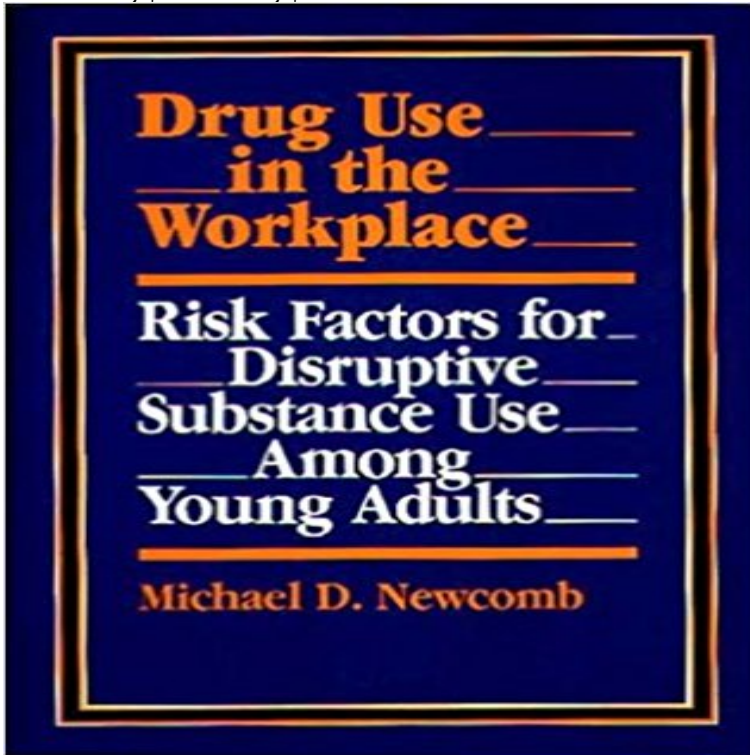


Drug Use in the Workplace: Risk Factors for Disruptive Substance Use Among Young Adults
