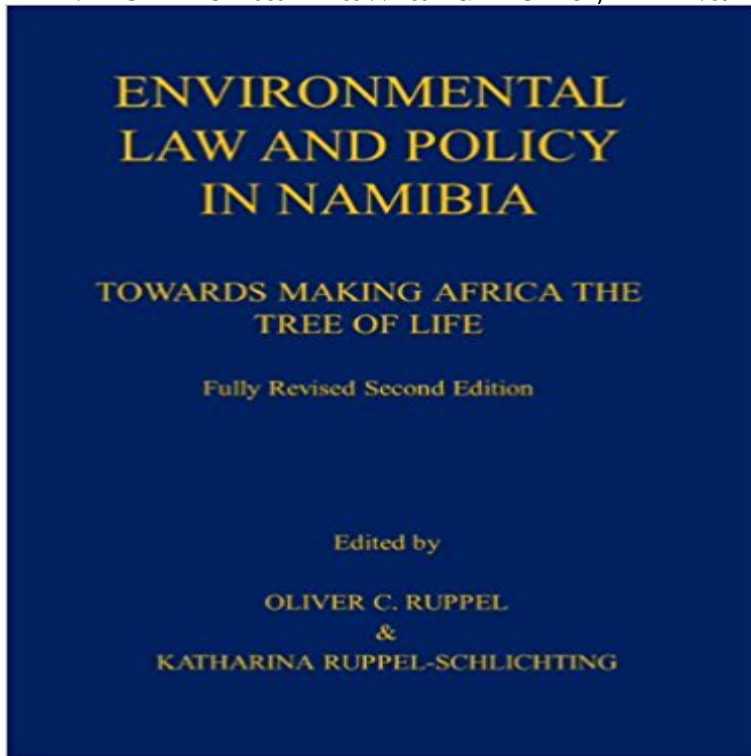


## Environmental Law and Policy in Namibia



Since Independence, environmental law has become an important branch of the law in Namibia. Over the past years new legislation has been passed and environmental law and policy has gained momentum practically and academically. Internationally, environmental law has also emerged from a soft law instrument to a key-negotiating platform in international diplomacy. Key features of this work are: national environmental law and policy; international environmental law, also focusing on environmental law within the African Union (AU) and the Southern African Development Community (SADC); environmental management; water and land law; conservation of biodiversity; mining and energy law, including renewable energy law; customary law, common law and criminal law aspects of environmental law; intellectual property rights and traditional knowledge; climate change; environmental justice and human rights; international trade, sustainable development and the environment; and environmental journalism. This publication is expected to be valuable for students, researchers, academics, legal and environmental practitioners, judges, government officials and anyone interested in this field be it from Namibia, Africa or beyond.
