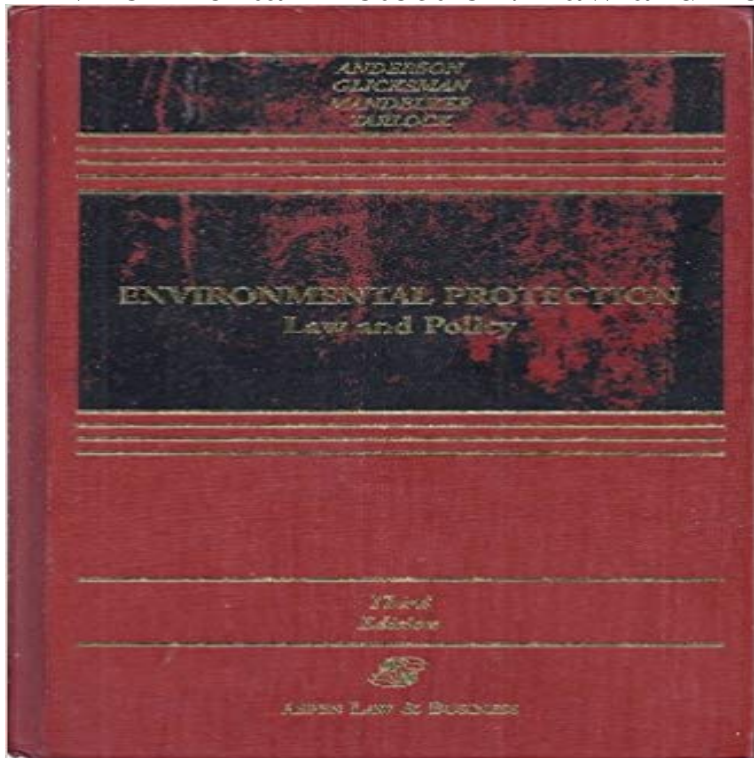


## Environmental Protection: Law and Policy (Casebook)
