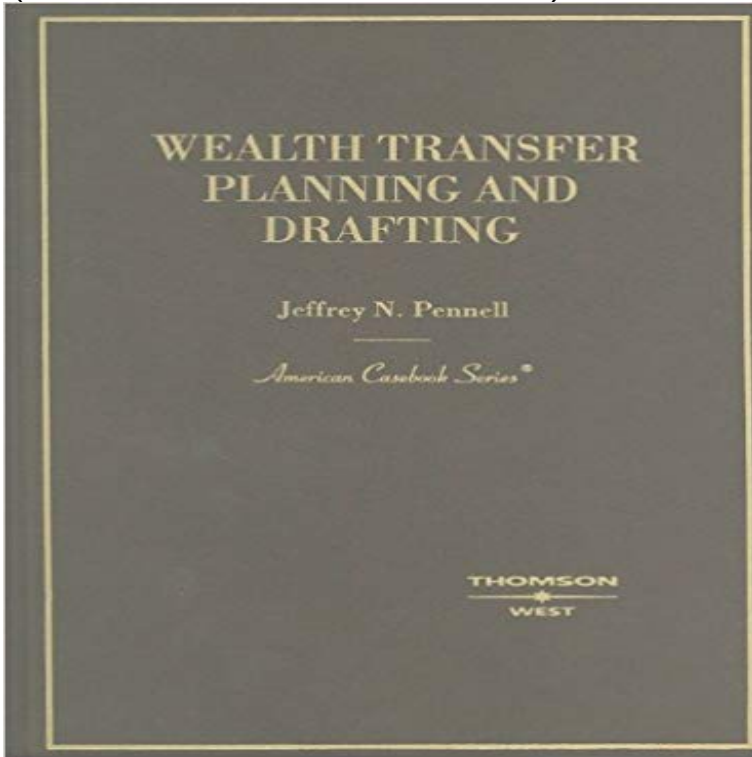


# Wealth Transfer Planning and Drafting (American Casebooks) (American Casebook Series)
