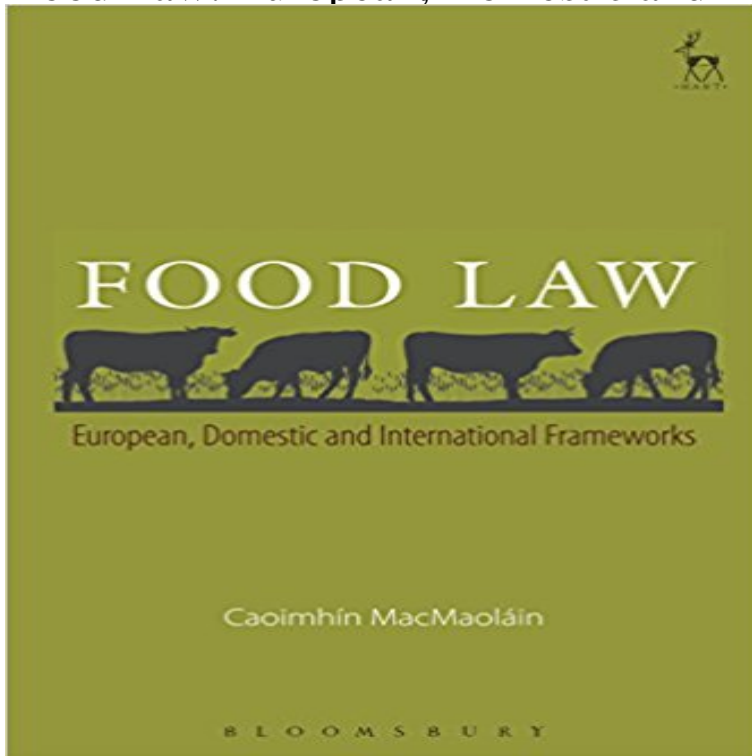


Food Law: European, Domestic and International Frameworks

It sets out to explain the impact of successive food crises, such as BSE and the use of horsemeat in beef products, on food safety, and transparency requirements. The book considers how the existing rules on the chemical and biological safety of food impact the law, and concludes with a review of the developing legal issues concerning the environmental impacts of current and proposed food law.
