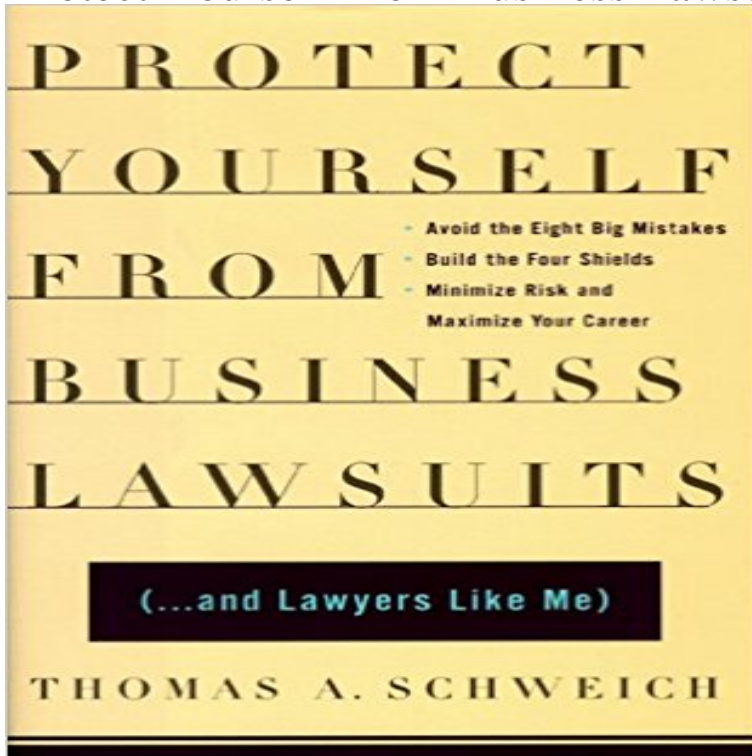


## Protect Yourself From Business Lawsuits: and Lawyers Like Me
