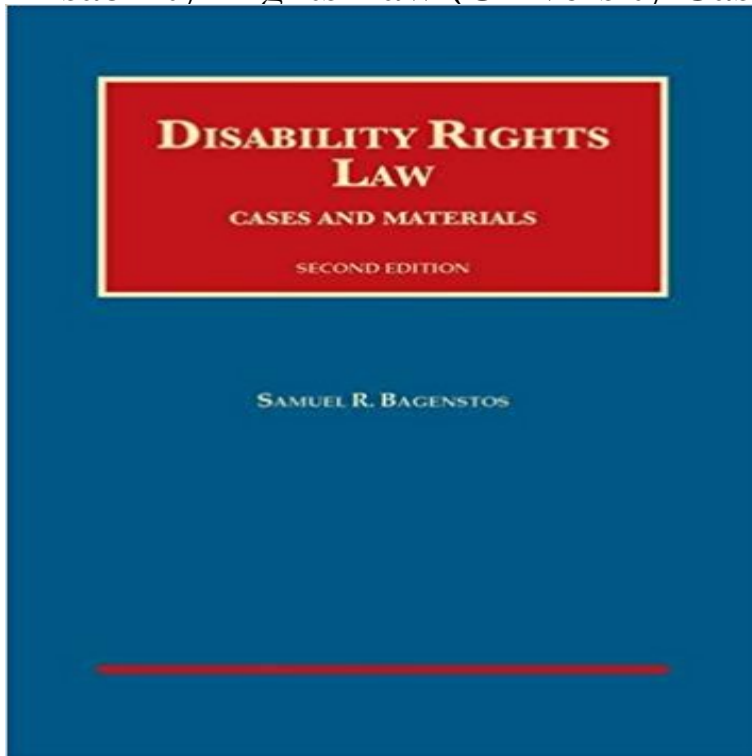


Disability Rights Law (University Casebook Series)
