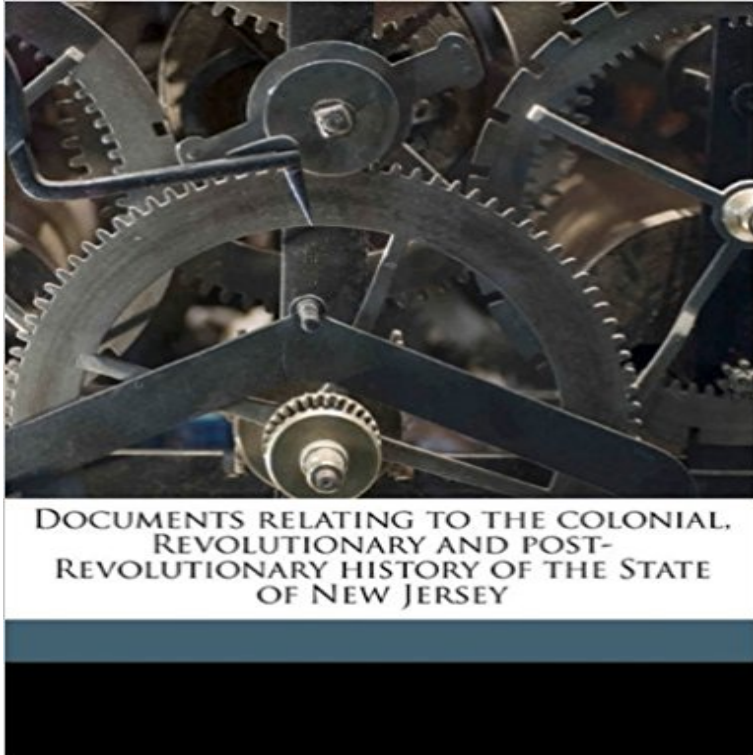


# Documents relating to the colonial, Revolutionary and post-Revolutionary history of the State of New Jersey Volume 9
