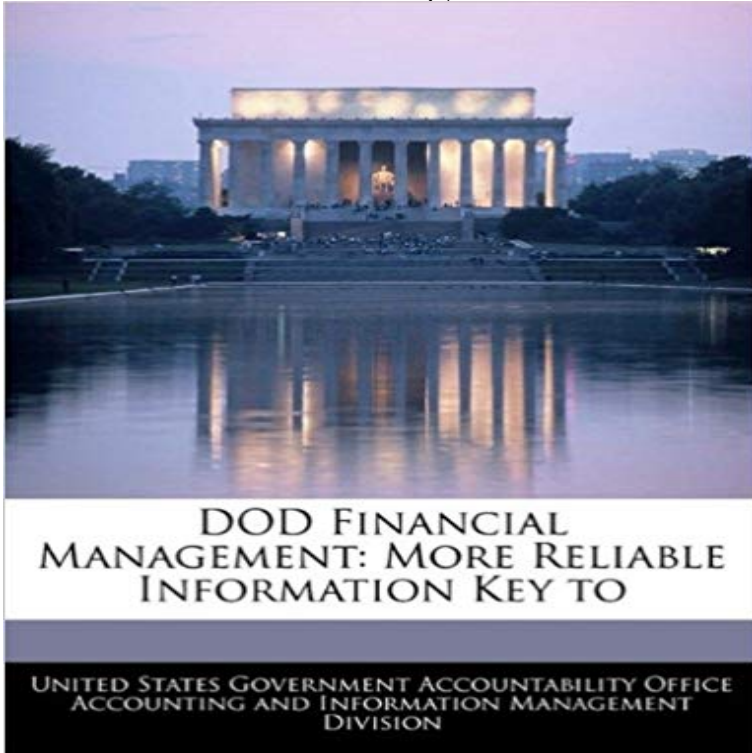


## DOD Financial Management: More Reliable Information Key to
