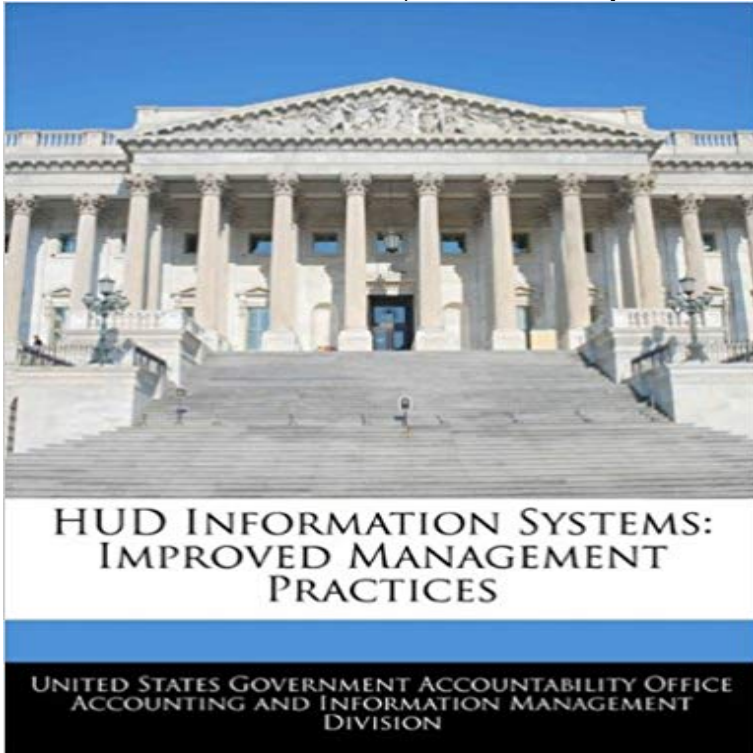


# HUD Information Systems: Improved Management Practices
