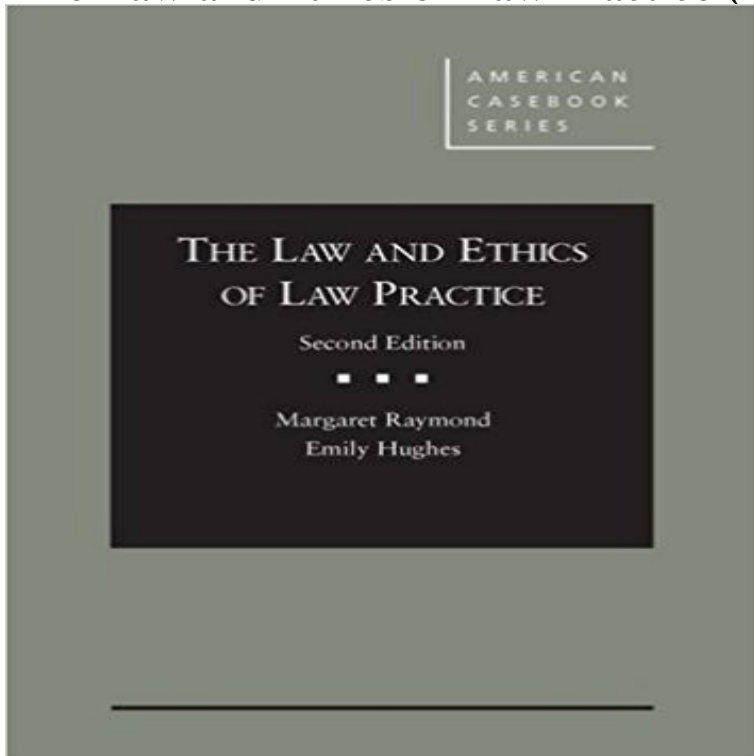


The Law and Ethics of Law Practice (American Casebook Series)
