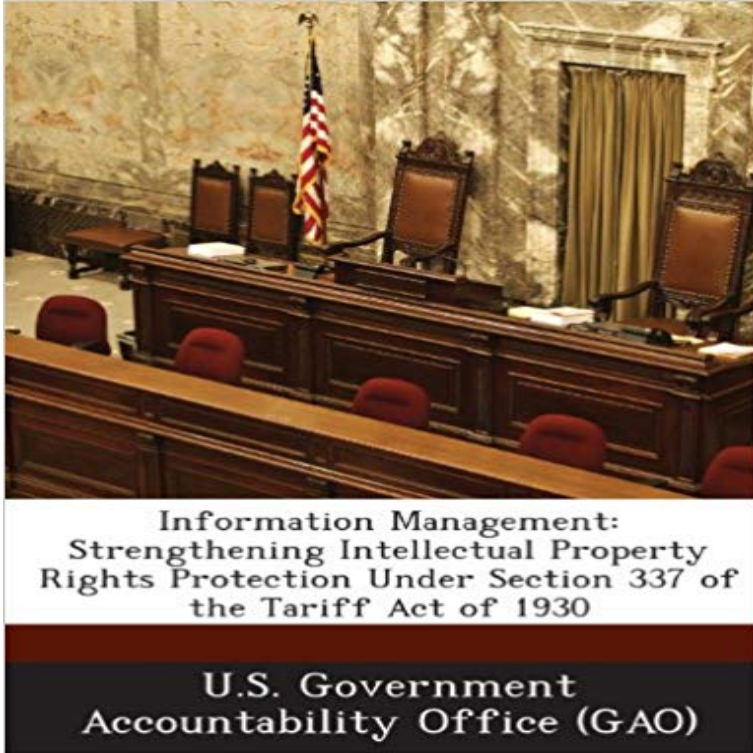


# Information Management: Strengthening Intellectual Property Rights Protection Under Section 337 of the Tariff Act of 1930
