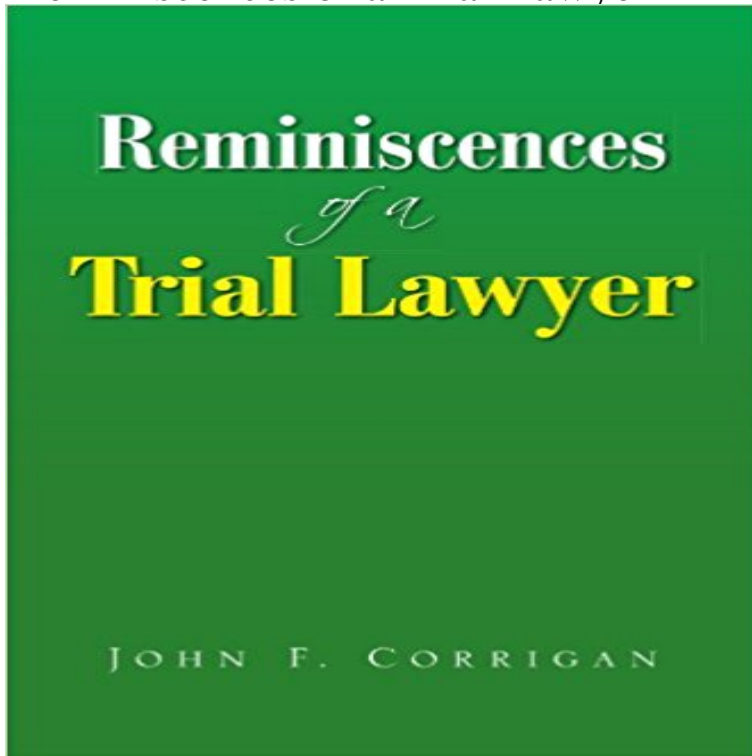


## Reminiscences of a Trial Lawyer
