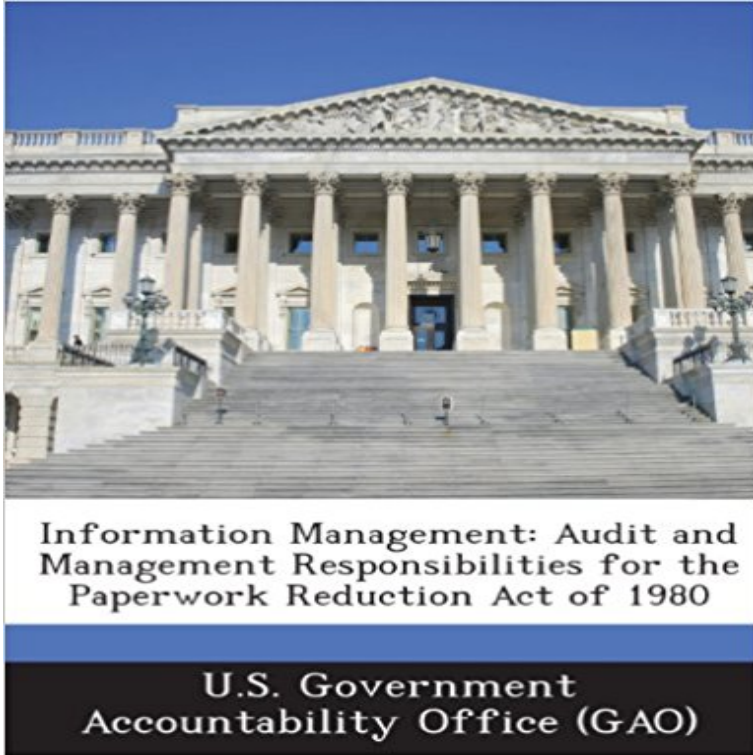


# Information Management: Audit and Management Responsibilities for the Paperwork Reduction Act of 1980

The Comptroller General of the United States is the leader of the GAO, and is appointed to a 15-year term by the U.S. President.
