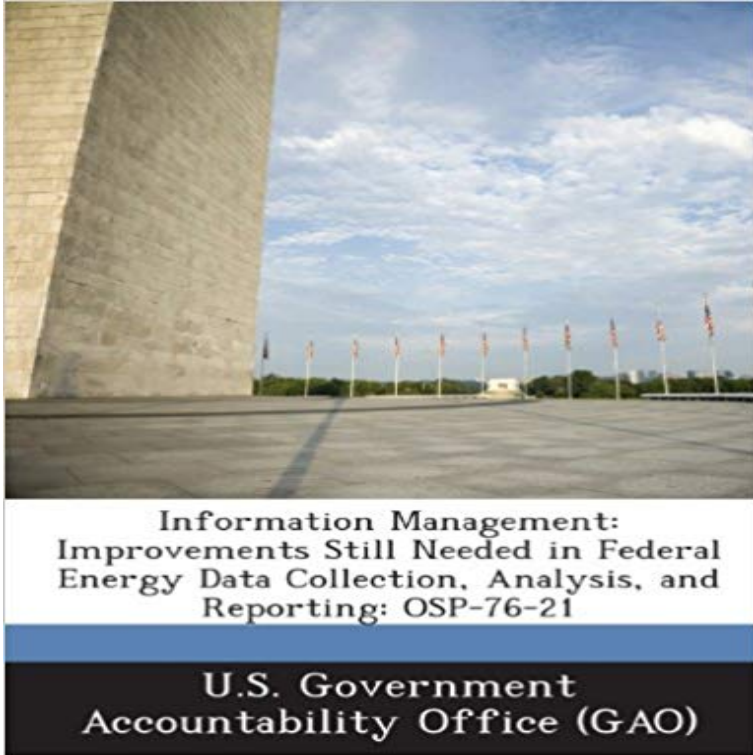


Information Management: Improvements Still Needed in Federal Energy Data Collection, Analysis, and Reporting: Osp-76-21
