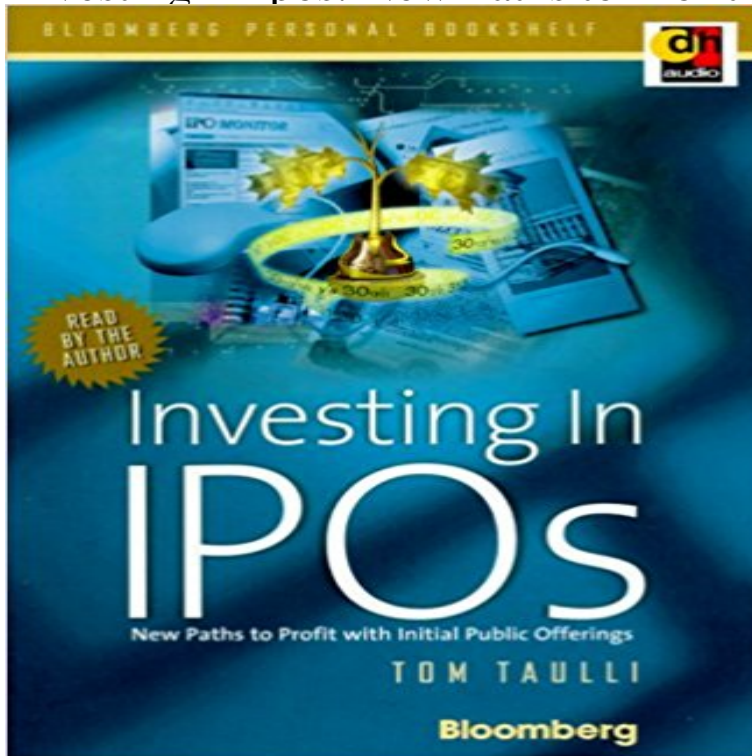


## Investing in Ipos: New Paths to Profit With Initial Offerings
