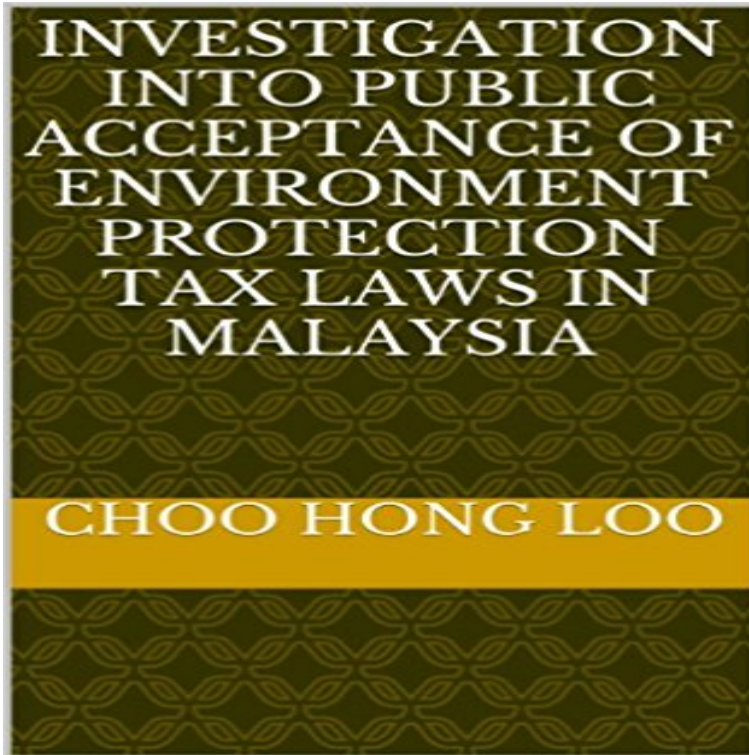


INVESTIGATION INTO PUBLIC ACCEPTANCE OF ENVIRONMENT PROTECTION TAX LAWS IN MALAYSIA
