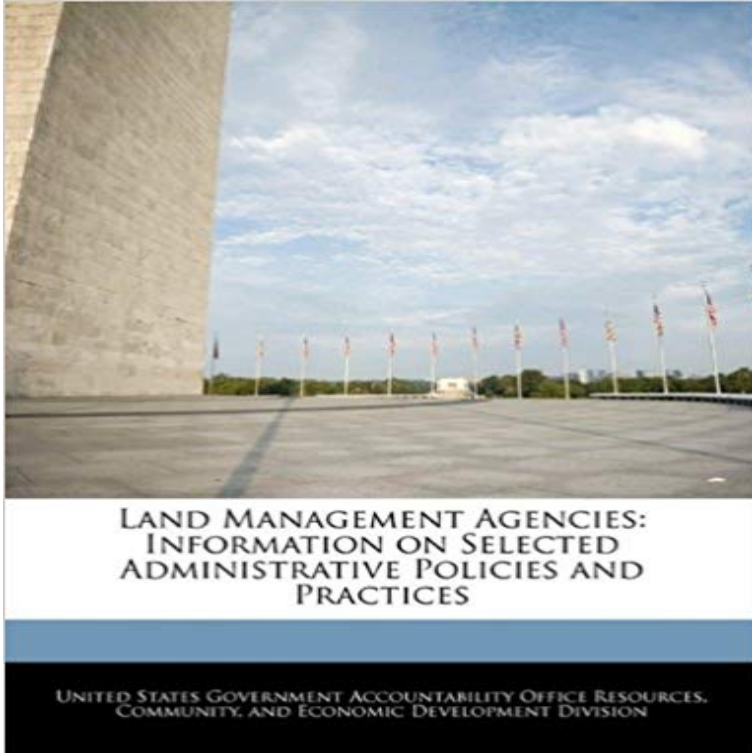


Land Management Agencies: Information on Selected Administrative Policies and Practices
