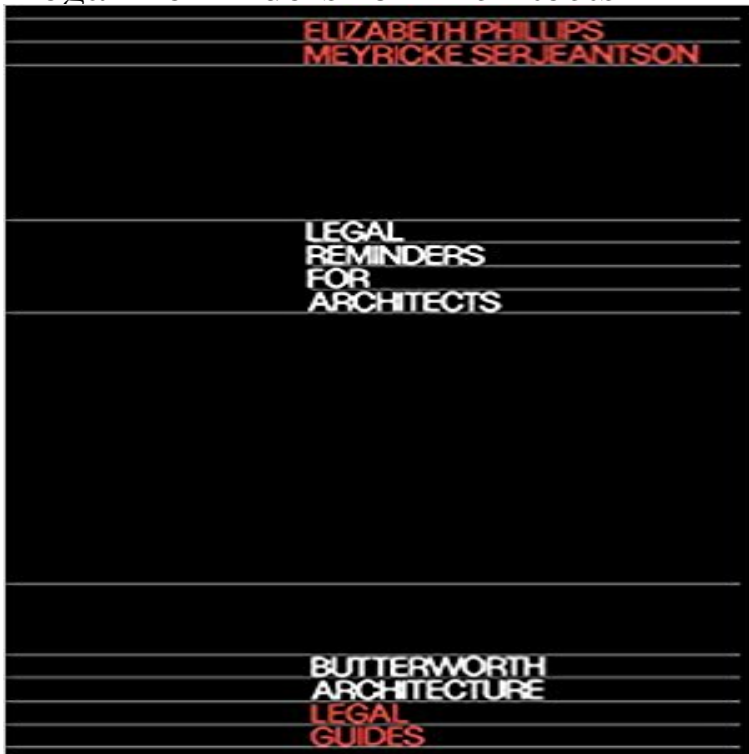


Legal Reminders for Architects

This book is intended for use by architects and architectural students.
