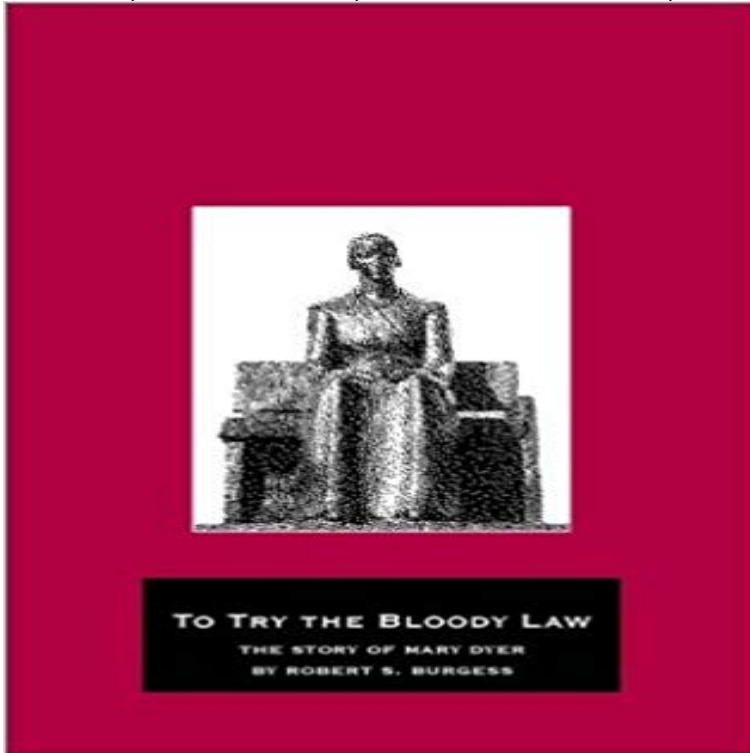


## To Try the Bloody Law: The Story of Mary Dyer
