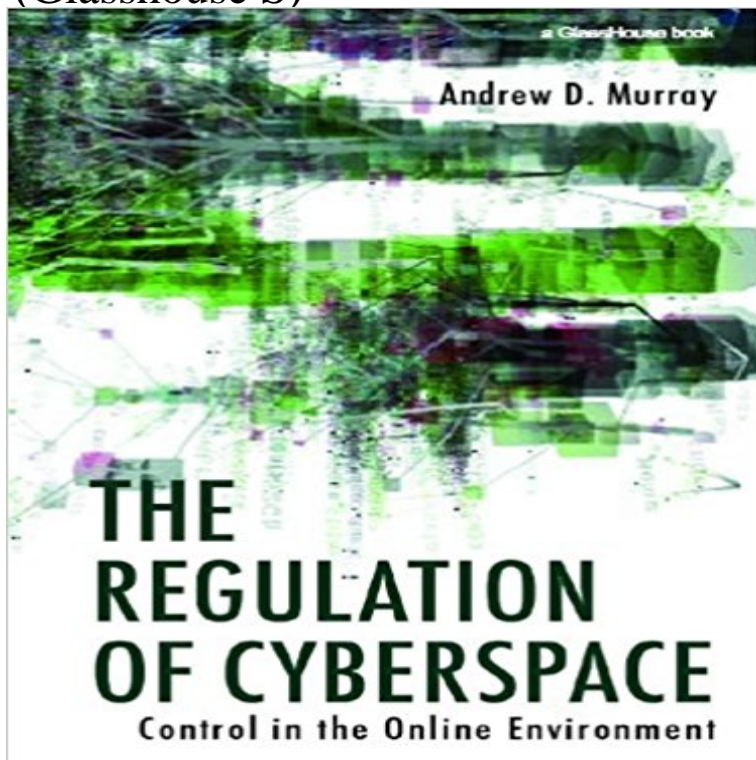


The Regulation of Cyberspace: Control in the Online Environment (Glasshouse S)
