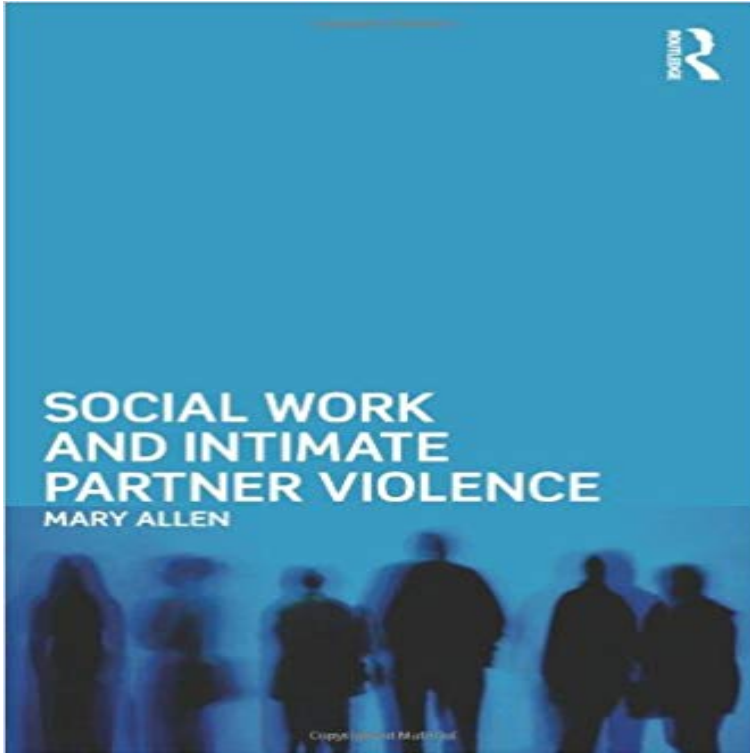


## Social Work and Intimate Partner Violence



Intimate partner violence is now recognised as a serious human rights abuse and increasingly as an important public health problem with severe consequences for women's physical, mental and sexual health.
