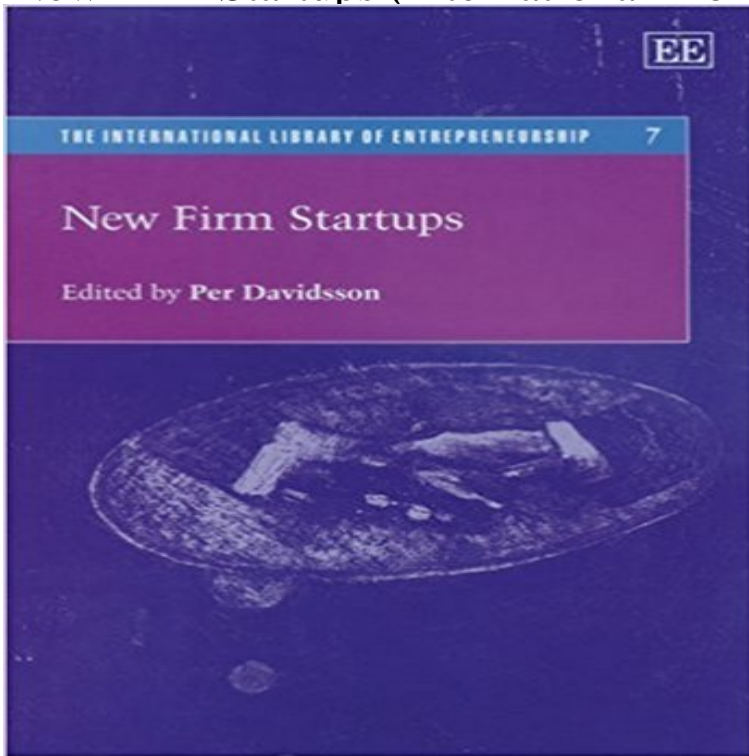


New Firm Startups (International Library of Entrepreneurship)
