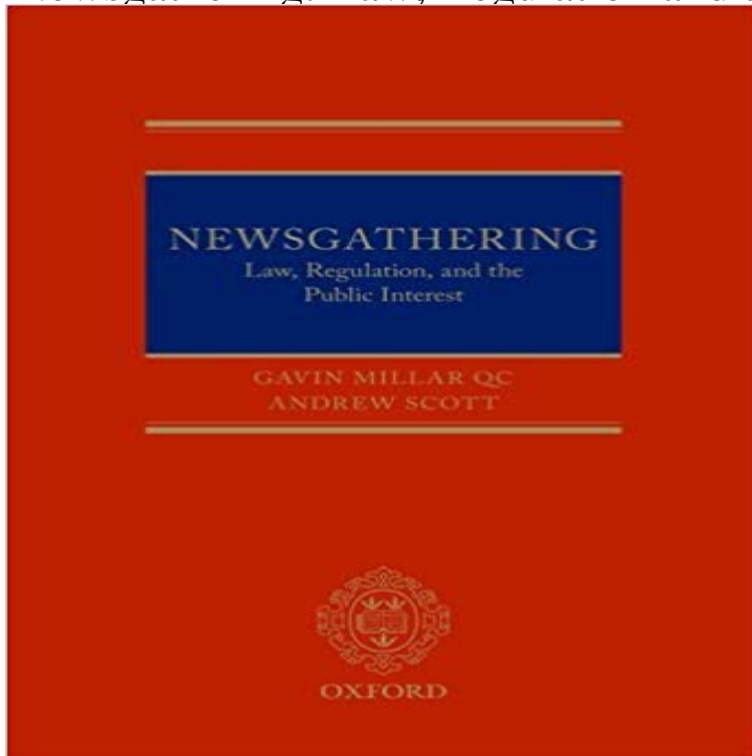


Newsgathering: Law, Regulation and the Public Interest
