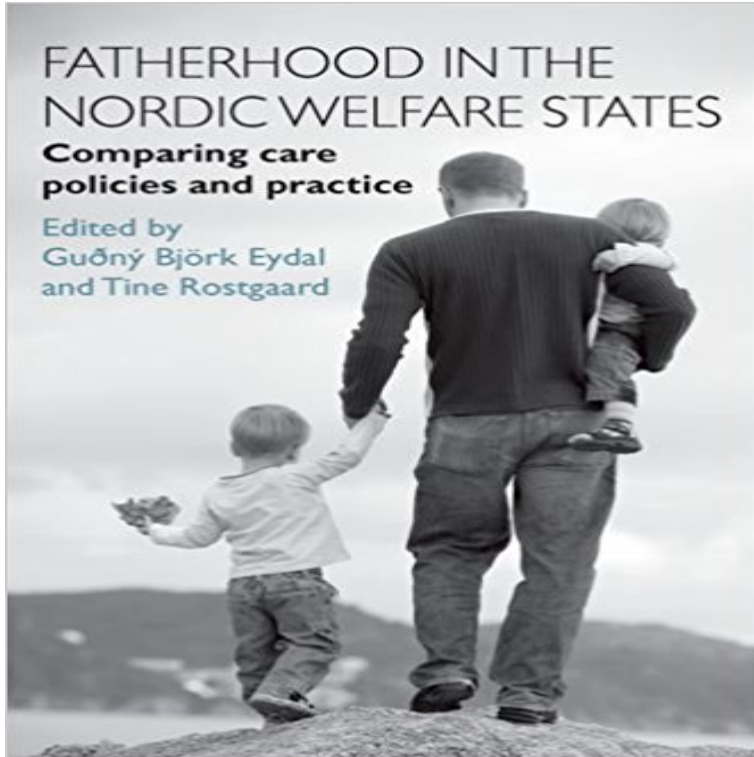


Fatherhood in the Nordic Welfare States: Comparing Care Policies and Practice
