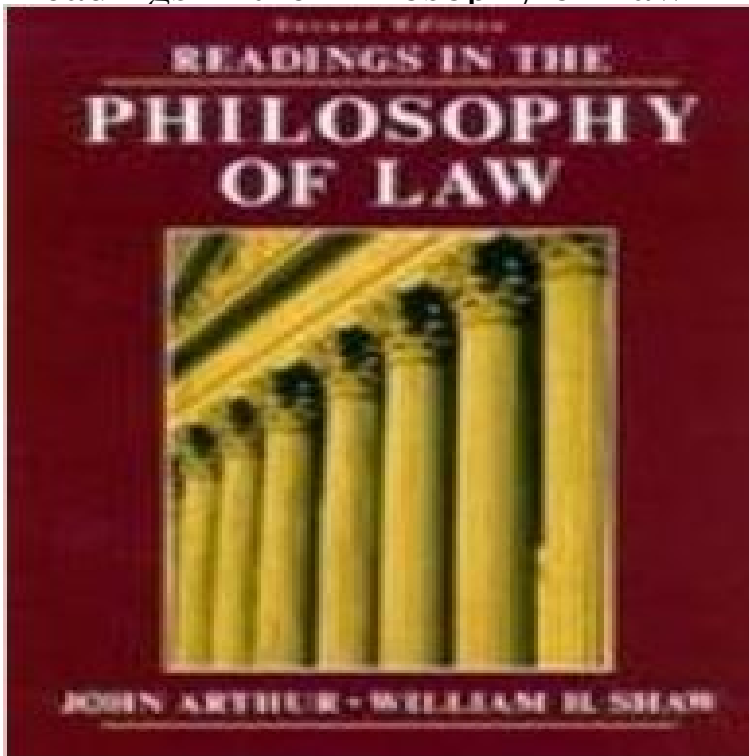


## Readings in the Philosophy of Law
