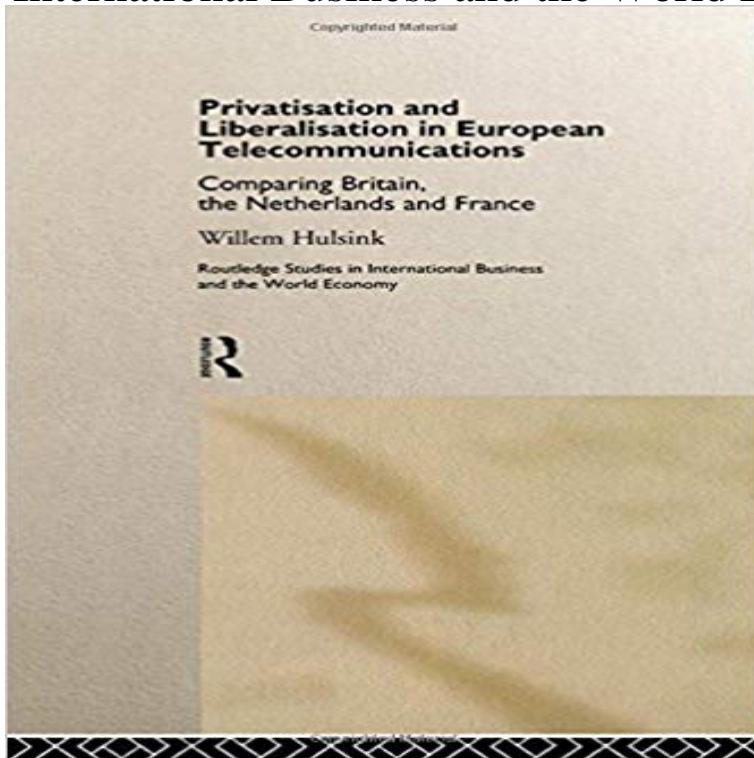


Privatisation and Liberalisation in European Telecommunications: Comparing Britain, the Netherlands and France (Routledge Studies in International Business and the World Economy)
