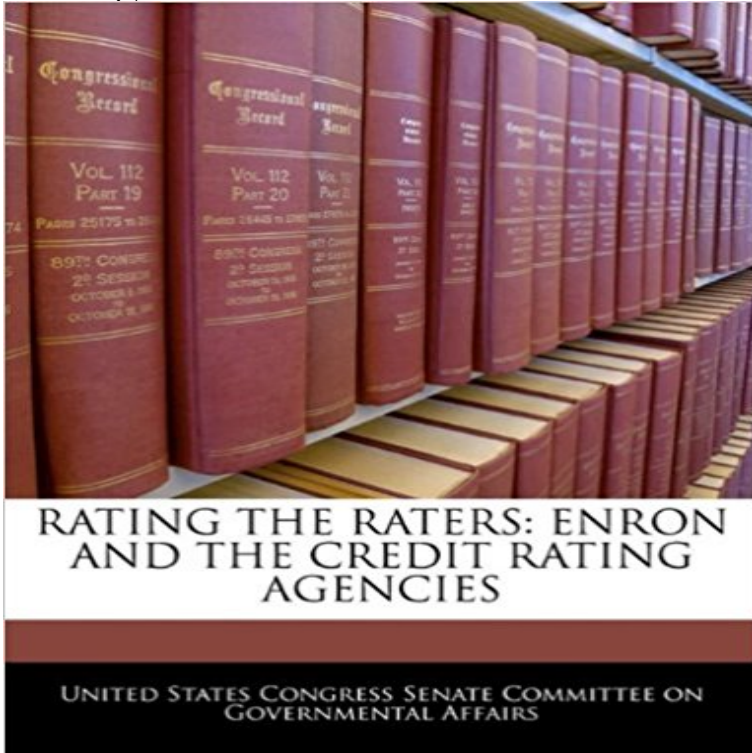


## Rating The Raters: Enron And The Credit Rating Agencies
