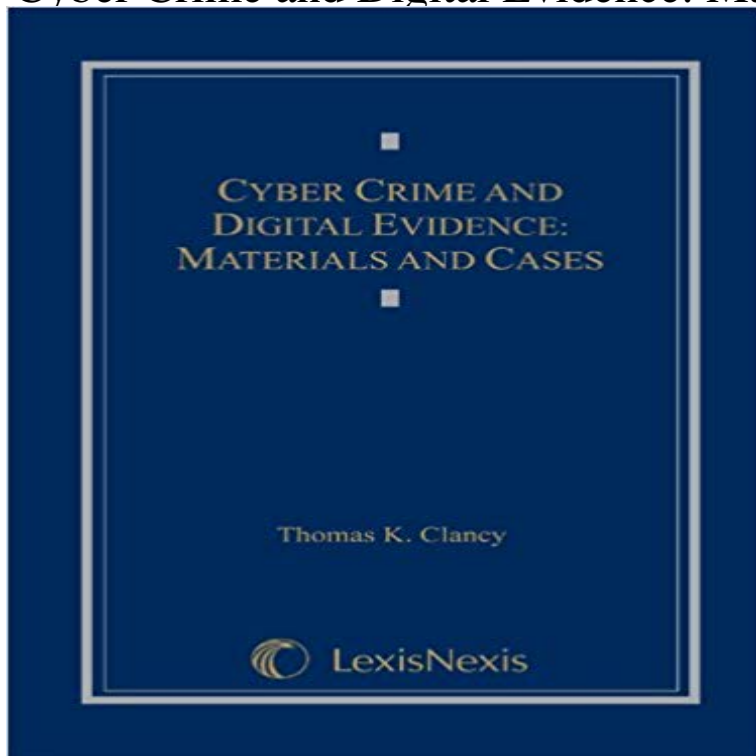


Cyber Crime and Digital Evidence: Materials and Cases
