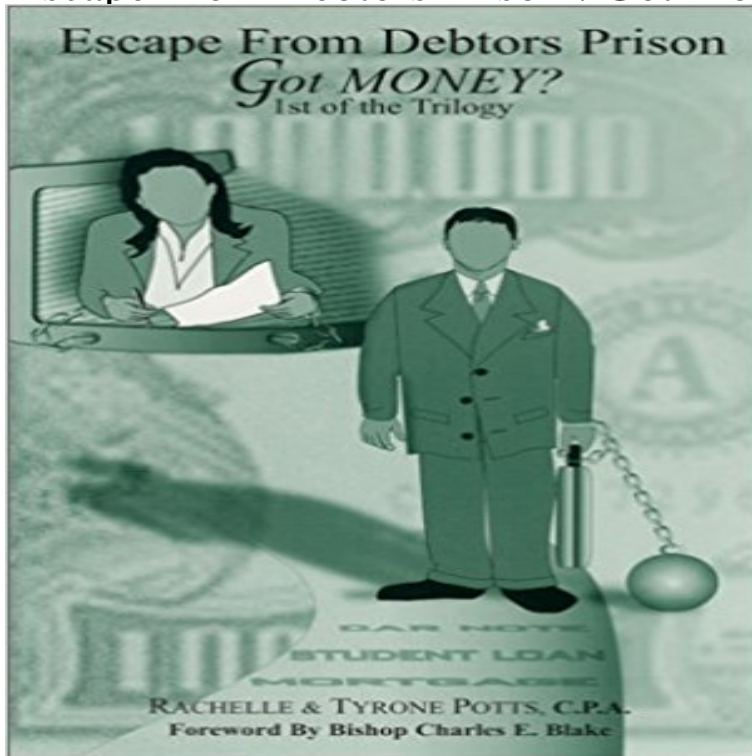


## Escape From Debtors Prison : Got Money?
