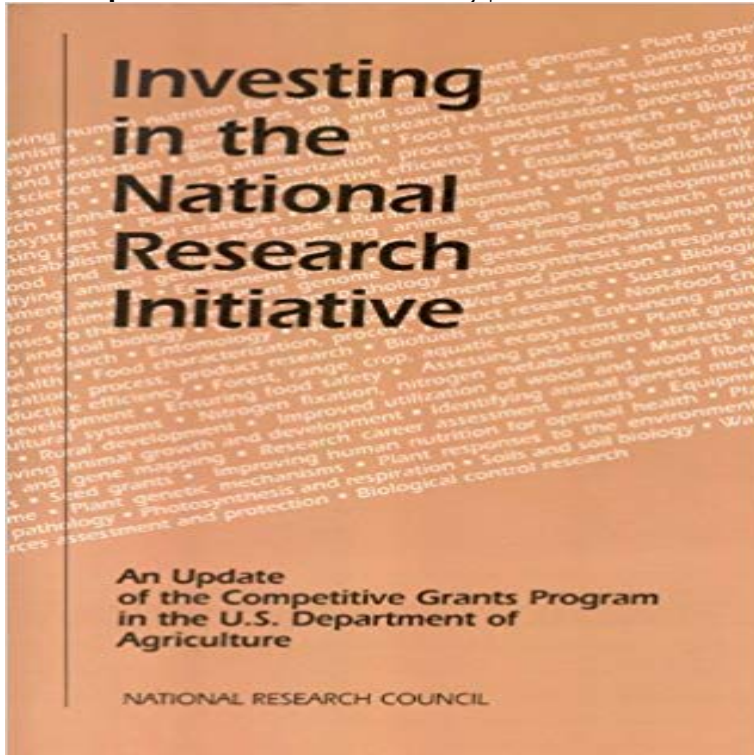


Investing in the National Research Initiative: An Update of the Competitive Grants Program in the U.S. Department of Agriculture



The Board on Agriculture (BA), in this self-initiated study, reaffirms recommendations it made for the U.S. Department of Agriculture supported competitive grants program in its 1989 report *Investing in Research: A Proposal to Strengthen the Agricultural, Food, and Environmental System*. Although the National Initiative for Research on Agriculture, Food, and Environment expanded following the BAs 1989 report, it has achieved neither the program breadth nor the \$500 million annual funding level recommended. The books discussion of competitively awarded grants as a mechanism to support high-quality research broadly related to agriculture, food, and natural resources dovetails with current efforts to craft the research component of the 1995 Farm Bill.
