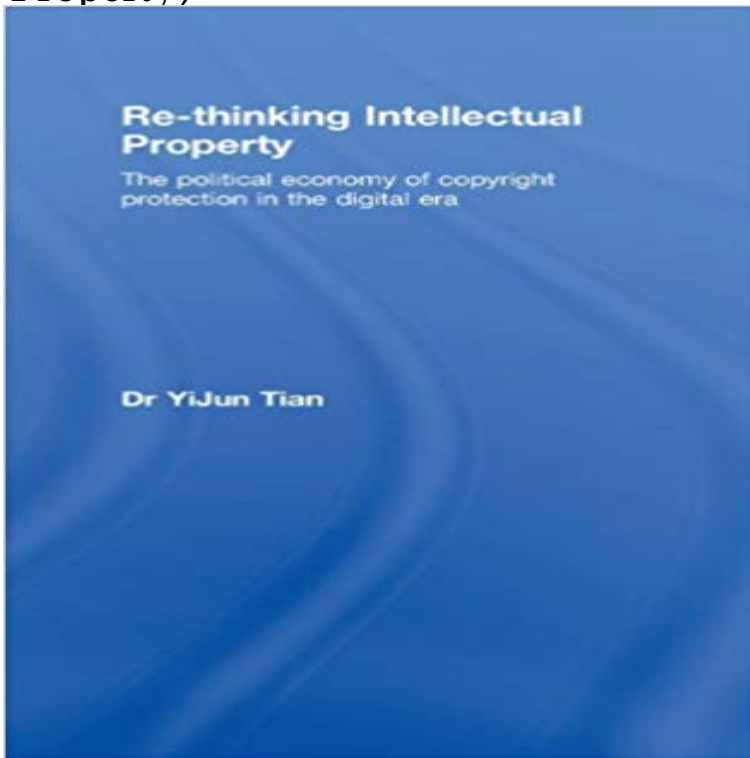


Re-thinking Intellectual Property: The Political Economy of Copyright Protection in the Digital Era (Routledge Research in Intellectual Property)
